SOSIA TRANSACTIONS DURING THE ENHANCED COMMUNITY QUARANTINE
(March 23, 2020)

1. References:

- a. PRRD Proclamation No. 929 re: Declaring a State of Calamity Throughout the Philippines Due to Coronavirus Disease 2019 dated March 16, 2020;
- b. Memorandum from Executive Secretary, with subject Community Quarantine Over the Entire Luzon and Further Guidelines for the Management of the Coronavirus Disease 2019 (COVID-19) Situation dated March 16, 2020;
- c. Section 11 & 12 of Republic Act 5487, as amended empowering the Chief, PNP and Local Chief Executives to deputize/utilize private security personnel in times of disasters/calamities; and
- d. Chief, PNP Approved Memorandum from Director, CSG, with subject: Recommendations Pertaining to the Enhanced Community Quarantine dated March 17, 2020.

2. President RODRIGO ROA DUTERTE has ordered an Enhanced Community Quarantine throughout Luzon beginning midnight of March 16, 2020 until April 12, 2020, in order to direct all government agencies and LGUs to render full assistance and cooperation with each other as well as mobilize essential resources to undertake critical, urgent, and much needed disaster response aid and measures in a timely manner to curtail and eliminate the threat of corona virus disease (COVID-19).

3. In support to PRRD's proclamation, the Chief, PNP has approved the recommendation of Chief, SOSIA through the Director, Civil Security Group, of the following, to wit:

- a. Extension until April 12, 2020 on the temporary suspension of SOSIA transactions for all Luzon based Regional Civil Security Units (RCSUs 1 to 5 and Cordillera);
- b. Those with License to Exercise Security Profession (LESP) and License To Operate (LTO) expiring within the Enhanced Community Quarantine period is given until after the end of the enhanced quarantine period or until April 12, 2020, without incurring any penalties;
- c. All Security Guards (SGs) shall continue to perform their mandated tasks and act as PNP Force Multipliers, provided that they are officially on duty, in uniform and can present their valid ID/LESP, Duty Detail Order (DDO) and other pertinent documents.
